Our branches are developing a national relationship with the charitable organisation All Heart. This helps our customers to repurpose their unwanted furniture products to community projects and not-for-profit businesses. It helps to contribute to the circular economy, and diverts waste from landfill.

At **OFFICE PRODUCTS DEPOT**, we are currently calculating our Carbon Footprint. This will help us to identify areas that we can improve on in our journey to becoming a more sustainable business.
